



# WILMER REGATTA 2007

November 3 & 4, 2007

**Organizing Authority: Lake Norman Yacht Club**

Exclusively for the Members of Lake Norman Yacht Club, Outrigger Yacht Club, and Peninsula Yacht Club

**Rules:** The Regatta will be governed by the current Racing Rules of Sailing (RRS), the Wilmer Trophy Deed of Gift, and this Notice of Race except as altered by the [LNKC Lakewide Sailing instructions](#). Two races are scheduled. The races will be a minimum of 8.9 miles each with a time limit of three and one half hours for the [spinnaker](#) fleet only. Non-Spinnaker boats may compete for the Wilmer Trophy, but must register and race in the Spinnaker fleet.

**Eligibility:** Open to all Keelboats domiciled on Lake Norman with a current LNKC rating certificate and the entrant is a member in good standing of LNYC, OYC, or PYC. If the vessel has not yet been rated, please submit pertinent information to the Lake Norman Keelboat Council at: <http://www.lnkc.com/downloads.htm> to have a rating assigned. No rating will be subject to appeal or change after the Competitors' Meeting. Eligible competitors shall enter by completing and returning this entry form along with payment of the appropriate fees.

**Classes:** Entrants shall be divided into Spinnaker and Non-Spinnaker Fleets. Divisions will be based on the number of entries and will be posted as soon as possible after the Competitors' meeting. Declarations on the entry form shall not be changed after the Competitors' Meeting begins.

**Scoring:** The Low Point Scoring System A2 shall apply, except that all races shall be scored.

**Protests:** Protest forms shall be submitted to the protest committee no later than 30 minutes after the race committee's arrival at the Race Management Center (RMC) after each day of racing. Protest hearings will be held immediately thereafter upstairs in the RMC.

**Trophies:** Trophies will be awarded to the top two finishers in each division. The name of the overall winner in the spinnaker fleet will be engraved onto the Wilmer Trophy on display at Lake Norman Yacht Club. If the two races do not qualify under the Wilmer Deed of Gift, the Wilmer Trophy will not be awarded.

**Dockage and Club Use:** You are welcome to keep your boat at LNYC for the weekend. Any slip without pre-set dock lines is available for use. (Note that with the current lake level, some slips may be too shallow for some boats; please use caution.) Please try to keep transient docks clear, particularly at the ramps, as another regatta will also be in progress. Camping or staying on your boat is welcome. No pets, please.
