The Carolina Keelboat One Design Regatta and Ultimate 20 East Coast Championship is hosted by the Ultimate 20 Fleet #2 at the Lake Norman Yacht Club.

1. Rules: The Regatta will be governed by the Rules as defined in the Racing Rules of Sailing and Class Rules, except as altered by the Sailing Instructions.
2. Eligibility: This regatta is open to one-design keelboats 20' LOA or longer. A minimum of three boats shall constitute a class.
3. Eligible boats may enter by completing the attached form and sending it, together with the required fee, to Don Corey/CKOD, 7519 Mariner Cove Drive, Cornelius, NC, 28031 by November 2, 2011. Late entries will be accepted when submitted prior to the end of the late registration with a \$20 late fee.
3. Fees: \$55 per Boat (registrations received on or before 11-2-11)
