The Carolina Keelboat One Design Regatta & U20 East Coast Championship is hosted by Ultimate 20 Fleet #2 at the Lake Norman Yacht Club.

1. **Rules:** The Regatta will be governed by the Rules as defined in the Racing Rules of Sailing and Class Rules, except as altered by the Sailing Instructions.
2. **Eligibility:** This regatta is open to one-design keelboats 20' LOA or longer. A minimum of three boats shall constitute a class.
3. **Entry:** Eligible boats may enter by completing the attached form and sending it, together with the required fee, to Don Corey/CKOD, 7519 Mariner Cove Drive, Cornelius, NC, 28031 by November 2, 2012. Late entries will be accepted when submitted prior to the end of the late registration with a \$40 late fee.
4. **Fees:**
  - \$35 per Boat (registrations received on or before 11-2-12)
  - \$75 per Boat (registrations received after 11-2-12)
  - Non-US Sailing Member add \$5
  - Saturday dinner \$14 per person
5. **Schedule of Events:**
  - Club Grounds Open: Friday, November 9, 2012 1700
  - Late Registration & Check-in at Clubhouse: Friday, November 9, 2012 1800 – 1900
  - Friday night Social at Clubhouse: Friday November 9, 2012 1800 - 2000
  - Late Registration & Check-in at Clubhouse: Saturday 0800 - 0900 (with coffee & pastries)
  - Skippers Meeting: Saturday 0945
  - Saturday First Warning Signal: Saturday 1130
  - Dinner at clubhouse: Saturday 1830 (or after racing)
  - Sunday First Warning Signal: Sunday 0930 (or as posted)
  - Sunday awards (after racing)
6. **General Information:**
  - Classes Expected: Ultimate 20, J/24, J/70, J/80, VX, Viper 640
  - Pets: Please note, "NO PETS" allowed (LNYC Rules)
  - Camping: Permitted on Club Grounds
7. **Sailing Instructions:** Will be available at Check-In.
8. **Race Area:** The racing area will be on Lake Norman in close proximity to the Lake Norman Yacht Club.
9. **The Courses:** The courses to be sailed will be windward-leeward, around the buoys.
10. **Scoring:** Low Point System; Appendix A2 of the racing rules will apply, except that all races will be scored with no throw outs. Five races are scheduled. One race completed, shall constitute a regatta. This changes RRS A2.
